## A CHRISTMAS MEMORY

Rays of Robbins was demolished this year. Rays was a fine department store on the corner of S. Middleton Street and Salisbury Street when I lived in Robbins 68 years ago. I have fond memories of the store for several reasons, one being, Mrs. Ray allowing several of us teenagers to work in her store during the Christmas holidays. Our earnings didn't usually make it home. We spent them before we left the store; mostly on sweater sets for each other. We all looked quite stylish after our gifts were opened on Christmas morning. But, the grateful memory I have of Rays that endures is the gift that Mrs. Ray gave to the whole town. Every year she would give to all of us little Christmas Carol books. They were pretty little books, small enough to hold in one hand while holding a candle in the other as we went caroling throughout the community. I think of the times we came together in the middle of town to sing "O Little Town of Bethlehem" and "Silent Night" before going caroling to the shut-ins. Somehow several of my little books have survived for many Christmases and through many moves. Each year I bring out my Christmas books, reserving a special place in my glass top table for my little books that are printed with Rays of Robbins on the first inside page. When I married and moved from my little town of Robbins—a delightful Southern mill town—61 years ago, I never dreamed that I would be back in Moore County 42 years later. The change has been drastic, but the loving memories remain of a generous store owner whose gift to our community brought much joy to our little world in northern Moore county.

- Newly elected elders to the class of 2019 will be invited to the December meeting of session.

Notes to Financial Statement - October 2016

- 1. Cash on Hand remaining after subtracting Unreserved Fund/Liability Accounts is \$21,060.45. This balance is \$781.15 less than September. This includes Non-Profit Checking and Money Market Account which includes the Gift Account. The balance in the Gift Account is \$15,790.87. The balance in Non-Profit checking was \$2,595.63 at month end. The balance in Non Profit Checking is \$922.10 less than the end of September. No money was transferred from the Money Market account to Non Profit Checking in October. The balance in the Money Market Account at month end was \$11,309.16
- 2. The Endowment Fund lost \$17.58 in October but the Investment Account increased \$473.31. The detail is reported on the Designated Accounts Report.
- 3. Pledges were \$2,172.00 over budget for the month and \$7,271.00 over budget YTD thru October. Income for the month was \$3,038.30 over budget and \$13,572.60 over budget YTD thru October. Expenses for the month were \$781.15 greater than income and \$352.95 over budget. The projected loss for the month was \$3,466.50. The loss Year to Date is \$10,023.93 but was projected to be \$27,798.00. We did not receive the October rent from the Seventh Day Adventist until November 3<sup>rd</sup> which was too late to be included in the October income.
- 4. Payroll was higher this month because of 5 weeks in the pay period but the office was not over the amount of hours for a week.
- 5. Office printing was over due to 3<sup>rd</sup> quarter printing being paid in October and the payroll.
- 6. Worship & Music is over budget due to payroll.
- 7. Christian Education is under budget due to adult Sunday School Class paying for books.
- 8. House and grounds is \$212.12 under budget for the month. Electric bill was \$73.19 over budget which was much better. Water bill was high again, \$183.84 over budget. Jim is still working to figure out why the water bill is so much higher. Yard care was \$100.00 over budget.
